Refrigerant Disposal Information and Verification

To qualify for the additional \$70 refrigerant recycling rebate, you must provide proper proof of refrigerant disposal. There are a variety of options available to you. *Please note, DMEA does not guarantee that the list below is all inclusive and/or current:*

- 1. City of Montrose Public Works Department - (970) 240-1480, 1221 6450 Rd., Montrose**
Residents of Montrose can have their refrigerator/freezer picked up for a \$15 fee. The refrigerant evacuation is an additional \$20. The fees must be paid at Montrose City Hall at 433 S 1st Street. City and/or county residents can bring their refrigerator/freezer to the Montrose public works department at 1221 6450 Road and avoid the \$15 pick up fee. County residents are not eligible for pick up. At the time of drop off, you must have a city representative sign the form below. If your refrigerator is picked up, you may submit a copy of your city utility bill showing the fees you paid for pick up and refrigerant evacuation. The City of Montrose Public Works hours are Monday – Thursday, 7:00am – 6:00pm.
- 2. Delta County Landfill – (970) 835-4470, 12211 Trap Club Rd., Eckert**
Delta County residents can take their old refrigerator/freezer to the Delta County Landfill located at 12211 Trap Club Road, Eckert, CO, Monday – Saturday, 8:00am – 4:00pm. There is a \$25 charge. A landfill attendant must sign the form below.
- 3. Local Appliance Stores**
Check with the store you are purchasing your new refrigerator/freezer. Some will remove and evacuate your old appliance as part of their customer service program. If so, a store representative must sign the form below.
